Andrew Fleck Children's Services is looking to hire a Resource Consultant to work in our Children's Inclusion Support Services (CISS) program. In this role you will work closely with licensed community child care programs and families in meeting the needs of including children with special needs.

For the first three years, this specific position will work on a special project to expand outdoor play opportunities in natural settings for young children enrolled in AFCS' Forest Explorers program, on a project with the Canadian Centre for Outdoor Play.

As the Resource Consultant your role will be to improve quality participation of children living with disabilities in outdoor play and learning in natural environments, in collaboration with the CCOP partnership, consisting of the Healthy Active Living and Obesity Research Group (HALO) at the Children's Hospital of Eastern Ontario (CHEO) Research Institute, Andrew Fleck Children's Services, Algonquin College, and Outdoor Play Canada (OPC).

You will advise and consult with child care program staff, families and the staff of community agencies to develop appropriate team service plans. You will provide formal and informal training to facilitate the inclusion of children with special needs in licensed child care settings.
